The Policy Forum on Development (PFD) was in 2013 as a established space for multistakeholder dialogue on EU development policies. The PFD puts into practice the commitment of the Lisbon Treaty to maintain regular and transparent dialogue and provisions from the EC communications on Civil Society in external relations and on empowering Local Authorities, as well as international commitments to achieve development effectiveness. It is the direct result of a 14-month structured dialogue with development actors from 2010-2011, which resulted in an institutionalised space for dialogue, co-created with civil society and local authorities.



The PFD is a platform that brings together civil society organisations, including professional and business associations, local authorities, representatives of EU institutions and Member States to discuss how the European Union (EU) can best implement sustainable development in partner countries via policy and regional programming. Recent discussions of the Policy Forum have focused on Global Gateway, the implementation of the regional NDICI-Global programming, the implementation of the third Gender Action Plan (GAP III), and broader topics around an enabling environment for civil society and local governments and SDG implementation. The Policy Forum on Development offers its members a space for open and transparent dialogue. It recognises everyone's specific expertise and helps to pool and multiply their knowledge and insights for the benefit of all.

How does the Policy Forum on Development work?

The Policy Forum works via a core membership of networks to bring experience and expertise to different aspects of the EU's sustainable development discussions. Meetings and consultations are held in person and online. In addition to its core membership, the Policy Forum currently hosts a Civil Society and Local Authority Advisory Platform on the Global Gateway, a steering group overseeing a structured dialogue on the implementation of the EU's Gender Action Plan III, an online dialogue space for the Youth Action Plan, and ongoing regular consultations on regional programming.

Before each meeting, Members reach out to their constituencies to collect input and positions relevant to the subject of discussion. In this way, a variety of development actors around the world can share their input, which is reflected in the discussions and recommendations of the Policy Forum.

The Policy Forum is run by a Task Team made up of regional and global civil society and local authority representatives, and EU staff (INTPA G2). They work with the support of a technical assistance facility to define workplans and agendas, prepare and organise online or in-person meetings.

- Policy dialogue with exchange of information and experiences, and consultation on key European Union sustainable development policies and initiatives
- Drafting key recommendations to share with representatives of EU institutions and other key development stakeholders
